

## **Guidelines and Information For The Beaumont Education Fund**

The Beaumont Education Fund ("the Fund") was established in 2019 by Lee Beaumont to:

- 1) To provide scholarships ("the scholarship") for prospective students of higher learning.
- 2) To promote education.
- 3) To use appropriate means consistent with the policies of the Fund, and,
- 4) To achieve the purposes of the Fund undergraduate and graduate programs of accredited universities and colleges in all fields of study and vocational programs of accredited trade schools

### **Eligibility**

To become eligible for a scholarship, a student must be accepted into an accredited university, college or trade school (or such other educational institute approved by the Board of Directors).

### **Specific Eligibility Criteria**

Be a Winnipeg based student that qualifies as a candidate in need of financial assistance and is willing to complete the Beaumont Education Fund Student Application and agree to all of the requirements and expectations of the Fund application as well as the agreement contained herein. It will be incumbent upon the high school to guide the applicant ("the student") in completing the form. This requirement will be waived for students who may qualify to apply directly to the fund should they have left high school.

### **Review and Selection**

Upon receipt of the applications the Board of Directors will chose a maximum of 3 qualifying candidates to receive a scholarship to a qualifying post secondary educational institution. From time to time at the Board's discretion the number of qualifying students may increase or decrease in any given year.

### **Scholarship Award**

The successful student applicant shall receive up to a maximum of \$5,000.00 CDN per annum for a maximum of 4 years or aggregate funding of \$20,000 per student. The Fund reserves the right to alter this amount by either increasing or decreasing the scholarship on a case by case basis. Scholarships may be used for tuition, study abroad programs, class fees, room and board, books or other educational expenses

Prior to any approval by the Board of Directors of the Fund and as part of the first time application, a bona fide copy of your most recent academic transcript is to be sent along with the submission of the Student Application which is separate and apart from the Guidelines and Information document.

Each scholarship is an agreement between the student and the Fund for a 1 year period. Upon the expiration of any one year period and on the basis the student wishes to apply for further scholarship support, the student shall present the Board of Directors with their most recent transcript, and such other documentation as reasonably requested by the Board of Directors. This re-qualifying information must be received by the Fund within 30 days after the official transcript is available from the qualifying educational institution. The Board will be setting up periodic video conferencing with all students throughout the year to remain connected to their progress, provide support and guidance, as well hear from fellow students in the program.

If a student withdraws or is dismissed from an institution, they must notify the Board immediately. The student is ineligible to request a renewal of their scholarship and that any monies rebated from the post secondary institution must be returned to the Beaumont Education Fund. However, the Board may, under certain circumstances, and at its sole discretion, consider a student's ongoing commitment and completion of a qualifying program to reapply for post Fund support.

Upon review of the students transcripts and unless notified by a member of the Board that a student is no longer eligible, all qualifying students will receive their annual financial support between August 15-31st. The scholarship will be mailed to your address of record, therefore, it is critical that you ensure we have your correct postal address as well as email
