Re: 2024 / 2025 Lunch Program Registration

Welcome to Bird's Hill School! Your child will be staying at school for the full day when they are in Kindergarten. This means that your child could be staying at school during the lunch break, if that is what you choose.

This is your Registration Package for the lunch program for the 2024 / 2025 school year. We encourage you to also read through the Policies and Expectations document which explains our program and contains important information.

Here are a few things to note:

Any student staying at Bird's Hill School during the lunch break, even once, including students travelling by school bus needs complete this registration form.

The Bird's Hill School Lunch Program (BHSLP) provides on-site supervision of students staying at the school during the lunch break. As lunch breaks are a parental responsibility, if your child is not registered in the BHSLP you must make other arrangements for your child(ren) during the lunch break.

Please return a completed Registration Form for each of your children, along with the applicable post-dated cheques (if required) to the school office no later than **Wednesday, June 12, 2024**.

Payment can be made with one cheque for all children in one family. Individual cheques for each child are not required. Please note child's / children's names on the cheque to ensure payment is applied correctly to each student.

KINDERGARTEN REGISTRATION OPTIONS

Please carefully consider the number of days of supervision your child will require in considering the following registration options. Refer to section 1.09 Refunds.

Full time: the student will regularly be eating lunch at school 7 days or more per month

Part time: the student will be eating lunch at school less than 6 days or less per month

My child will participate in the lunch program on the following basis (please check one):

- Full time:** 1 cheque for \$101.20 per child, due on September 1, 2024 or before.
- 2 cheques for \$50.60 each per child, due on September 1, 2024 and February 1, 2025.
- 5 cheques for \$20.24 each per child, due on the 1st of each month, Sept 2024 to January 2025.

- Part time:** 1 cheque for \$50.60 per child, due on September 1, 2024.
provides for 46 days of eating lunch at school. Approximately ½ of the school year.
- 1 cheque for \$25.30 per child, due on September 1, 2024.
provides for 23 days of eating lunch at school. Approximately ¼ of the school year.
- 1 cheque for \$11.00 per child, due on September 1, 2024.
provides for 10 days of eating lunch at school. Approximately 1 day a month of the school year.

You will be advised when you have five (5) days of use left.

Cheques are payable to: BIRD’S HILL SCHOOL LUNCH PROGRAM

Payment can be made with one cheque for all children in one family. Individual cheques for each child are not required. Please note child’s/children’s names on the cheque to ensure payment is applied correctly to each student.

Late payment will result in removal from the Lunch Program.
