I am also the district representative for recreational soccer under Winnipeg Youth Soccer Association. I have been involved in the soccer program for the past eight years. I have been a resident of this community for the past 20 years.

Park City C.C. is home to an average of 250 kids in the 9 & over program. We also take care of an average of 20 teams in the 8 & under program.
